- What is Advocacy?
 - The act or process of supporting a cause or proposal.
- What is an Advocate?
 - One who defends or maintains a cause or proposal.
- NOTE: There is no need to have any knowledge about the cause or proposal.
 - That is the job of the researcher or analyst.

What is the job of the Advocacy Researcher/Analyst?

- To provide content to the advocacy program or proposal.
- To make the content defensible.
- To give the advocate a talking point.
- Majority of Advocates <u>DO NOT</u>
 understand the data or information that
 provides for the talking point, but the
 content is necessary to provide
 legitimacy to the program or proposal.

My Role

- My role is to provide analysis on the impact political policies have on a state's economy.
- I work with all 50 states.
- I provide information on the impact that state budget changes, tax policy changes, and expenditure changes have on a state's economy.
- Especially how these changes affect education.



Policies Reviewed

- Tax changes
 - Cuts (e.g., Property, Income, Sales)
 - Increases (e.g., Millionaires tax)
- Expenditure changes
 - Cuts (e.g., across the board)
 - Increases (e.g., RDFs)
- Changes to programs (e.g., school vouchers)



Voucher Example

Arkansas' Universal Voucher Program

Provides a voucher to parents to send students to any school they desire (Public, Private, Secular, Religious).

Students receiving a voucher can be attending public, private or home school (different amount for home school).

Voucher is 90% of previous year's amount per-student for charter school students.

Voucher comes from the state General Fund only.
